Request for Waiver of Puc 203.09(f)

To the Parties:

On April 21, 2020, Lakes Region Water Company, Inc. (LRWC) filed a motion to waive the 10-day deadline contained in N.H. Code Admin. Rules Puc 203.09(f) for filing its responses to Commission Staff's (Staff) Set 4 data requests. In its motion, LRWC represented that Staff assented to its request. Staff filed a response to LRWC's motion on April 27, 2020.

Although LRWC's responses to the data requests were due on April 9, 2020, LRWC stated in its motion that it was unable to file the responses by this date due to circumstances beyond its control. LRWC noted that it provided its responses on April 20, 2020. It requested the Commission to waive Puc 203.09(f) and accept its late responses to Staff's data requests, stating that a waiver of the 10-day deadline would serve the public interest and would not disrupt the orderly and efficient resolution of matters before the Commission.

The Commission has reviewed LRWC's motion for a waiver of Puc 203.09(f) and determined that the standards for waiver contained in Puc 201.05 have been satisfied. Accordingly, LRWC's request to waive the requirements of Puc 203.09(f) has been granted.
