On behalf of Commission Staff (Staff) in the above captioned matter, I write in response to the Order of Notice filed in this docket on September 6, 2019. That order directs the parties to hold a technical session on September 16, 2019.

The parties would like to combine the technical session in this docket with a technical session in a second Liberty winter cost of gas (COG) matter that Liberty Utilities anticipates filing on September 16, 2019, for its Keene Division. Moving the technical session in this docket, DE 19-145, will permit the parties to hold a combined technical session, and will result in a more efficient process for all of the parties.

Staff spoke with Liberty Utilities, and with the Office of Consumer Advocate. They agree and concur with the request, and with Staff's proposed date and time. Accordingly, Staff respectfully requests the Commission to reschedule the technical session in this docket for a date one week later than the date identified in the Order of Notice, i.e. for September 23, 2019, beginning at 10 a.m.
