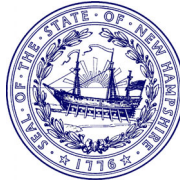

***Letter of Non-Compliance***

Dear Ms. McNamara:

Staff has reviewed the tariff filing received on June 4, 2021, and as revised by filings on June 25, 2021 and June 30, 2021 in the above-captioned proceeding. During review of the tariff filing, Staff found the following:

The cover letter does not explain the source of the summer rates Liberty added, presumably to be effective May 1, 2021. Liberty told Staff that Liberty billed Gas Assistance Program recipients based on cost of gas summer rates effective May 1, 2021. In addition, the date of the Order that approved the Gas Assistance Program changes in DG 20-013, referenced in the cover letter, is incorrect. It should be August 27, 2020.

Accordingly, Liberty's filing, as revised, is not compliant at this time. Please refile the revised tariff pages per Puc 1603.03; Method of Filing.

In accordance with the Secretarial letter issued March 17, 2020, this letter will be filed electronically only at this time.
