Re: Notice of Intent to Act as a Buyers' Aggregator

Dear Executive Director Howland

Pursuant to Puc 2003.05(a) of the New Hampshire Code of Administrative Rules, Budderfly, Inc. files this notice of its intent to act as a Buyers' Aggregator.

Budderfly, Inc. ("Budderfly" or the "Company"), is a Delaware corporation, with an address of 2 Trap Falls Rd., Suite 500, Shelton, Connecticut 06484. As explained below, Budderfly has a unique business model that, based upon our review of relevant New Hampshire law(s) and regulations, we believe qualifies Budderfly as a Buyers' Aggregator under Puc 2002.06 largely because Budderfly receives no compensation or remuneration from an electricity supplier.

Budderfly intends to provide energy management services to commercial establishments (not residential customers) at various locations across New Hampshire. The Company has developed an "Energy Management Outsourcing" model that includes, inter alia, becoming the customer of record with the local utility for each commercial establishment, and deploying energy efficiency equipment, upgrades and technology, a proprietary energy management hardware and software system, along with providing billing and other managed services to manage energy usage and reduce energy expense. As such, Budderfly is the utility customer and all of the above-noted energy efficiency measures are installed and operated behind the utility meter. Budderfly does not make use of the local utility's transmission or distribution system. Budderfly separately invoices the commercial establishments on a calendar month basis under contract terms that economically result in the Company and those establishments splitting the savings that result from the energy efficiency measures it has implemented. In addition to energy usage reductions, Budderfly intends to aggregate and place eligible accounts with a chosen supplier in order to help achieve even further energy cost reductions. In such instances, Budderfly would be the account holder and customer of record with both the supplier and the local utility and Budderfly receives no compensation or remuneration from an electricity supplier.

Budderfly understands that pursuant to Puc 2003.05 Registration of Aggregators.

(a) Any person or entity that acts solely as a buyer's aggregator, such as a municipality acting on behalf of its citizens, shall notify the commission of its intent to do business.
(b) With the exception of (a) above, a buyer's aggregator shall not otherwise be subject to the provisions of this chapter.

Moreover, Budderfly understands that there is no standard form required for such notice inasmuch as the Commission's Electric Load Aggregator Registration Instructions¹ provides:

We thought it might be helpful if we completed the form of registration for informational purposes as part of this notice that we intend to act as a Buyer's Aggregator. Therefore, a completed form is attached to this letter for informational purposes only.
