On July 31, 2020, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities filed a petition to implement new permanent rates effective September 1, 2020 and to set temporary rates effective October 1, 2020, and to amend various tariffs. The Commission issued Order No. 26,395 (August 19, 2020) which suspended the proposed tariffs and scheduled a pre-hearing conference and technical session for September 3, 2020 and a hearing on temporary rates for September 16, 2020.

The Office of Consumer Advocate (OCA) filed a letter on July 8, 2020 indicating its participation in the docket.
