Re: DG 20-105; Liberty Utilities (EnergyNorth Natural Gas) d/b/a Liberty Compliance Tariff

On behalf of Liberty Utilities (EnergyNorth Natural Gas) d/b/a Liberty (the "Company" or "Liberty") and in accordance with New Hampshire Public Utilities Commission (the "Commission") Order No. 26,808 (April 28, 2023) in Docket No. DG 20-105, I enclose for filing the following tariff pages reflecting approved adjustments to each of the rates in the above-referenced Order:

- Forty-sixth Revised Page 1
- Fourth Revised Page 2
- Forty-third Revised Page 3
- Forty-first Revised Page 4
- First Revised Page 41
- Twenty-third Revised Pages 87 and 89
- Twenty-fifth Revised Page 88
- Ninth Revised Page 101

As part of the preparation of the compliance tariff filing, the Company noticed an error in the language in the Order and the settlement agreement. Specifically, the language regarding the Rate Case Expenses/Temporary Rate Reconciliation Factor ("RCE") should read "the RCE is being changed from \$0.0044/therm to \$0.0111/therm for a \$0.0067/therm increase." The supporting schedules provided by the Company were correct, but the wording in the Order and settlement agreement are not correct.

Per Settlement Agreement, Section 8, "8. The Settling Parties agree, and propose that the Commission approve, that Liberty may begin collecting these rate case expenses through an \$0.0111 per therm *increase* to the Rate Case Expenses/Temporary Rate Reconciliation (RCE) factor of the LDAC beginning June 1, 2023," at 2 (emphasis added).



The sentence should read, "8. The Settling Parties agree, and propose that the Commission approve, that Liberty may begin collecting these rate case expenses through an increase to the Rate Case Expenses/Temporary Rate Reconciliation (RCE) factor of the LDAC of \$0.0111 per therm beginning June 1, 2023."

This language was carried forward in the PUC Order at 1 and 5. The Company would like to note the RCE is increasing **to** \$.0111/therm and not increasing **by** \$0.0111/therm.
