## **Procedural Order Re: Record Request**

During the January 18, 2022 hearing on the request for the first step adjustment in this matter, the Commission issued three record requests. On January 25, 2022, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) filed responses to these record requests marked as exhibits 58, 59, and 60, respectively. The Commission has reviewed the responses and determined that the response marked as exhibit 60 does not resolve the Commission's request. In order to develop a more complete record in this docket, the Commission directs Liberty to provide a response to the following:

60-a: Compare the rate base on January 1, 2020, to your estimate of the unconstrained rate base on January 1, 2021. Recalculate the rate base to be used for the first step increase by taking into account the level of depreciation that occurred in 2020 and compare it to the rate base proposed at the January 18, 2022 hearing.

Liberty is directed to answer this record request in writing and through the production of electronic Excel spreadsheets filed with the Commission and served on the parties on or before <u>February 14, 2022</u>.
