Dear Ms. Howland:

The parties in this proceeding, Comcast of Maine/New Hampshire, Inc. (Comcast) and Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications-NNE (Consolidated) have agreed with Commission Staff to recommend that the Commission adopt the following procedural schedule for this docket:

Stipulation of Uncontested Facts Filing	October 13, 2020
Consolidated Pre-filed Testimony Filing	October 26, 2020
Rolling Data Requests to Consolidated	Through November 2, 2020
Consolidated Data Request Responses	November 11, 2020
(Consolidated will respond to data requests received prior to Nov. 2 within one week)	
Comcast Rebuttal Testimony	November 23, 2020
Hearing on Merits	December 4, 2020 at 10:00 a.m.
Initial Legal Briefs	December 11, 2020
Reply Legal Briefs	December 18, 2020

Staff also recommends, based on the agreement of the parties, that the Commission approve the proposed procedural schedule relying upon the 360-day timeframe described in federal law at 47 U.S.C. §224(c)(3)(B)(ii), rather than the 180-day timeframe described in 47 U.S.C. §224(c)(3)(B)(i). *See Time Warner Entertainment Company L.P. d/b/a Time Warner Cable*, Order No. 25,387 (July 3, 2012) at 15-16.

Commission Staff, on behalf of the parties, hereby requests that the Commission approve the proposed procedural schedule in reliance on the 360-day timeframe described in 47 U.S.C. §224(c)(3)(B)(ii).
