Public Fire Protection (Hydrants) – Atkinson	\$9,287.00 per month for 12 months
Surcharge - Rate Case Expenses - All customers	\$4.37 per month for 18 months

TERMS OF PAYMENT:

These Surcharges will be in effect for each customer as noted above for the periods noted above per customer commencing November 17, 2022, or until the temporary/permanent rate reconciliation of \$186,036 and the rate case expenses of \$322,775.30 are collected, whichever is earlier. Bills under this rate are net and will be rendered monthly and are due and payable upon presentation. All accounts twenty-five (25) days past due will be assessed a late fee of Ten Dollars (\$10.00) at the discretion of the Company.
