Page 3 Check Sheet and Page 85 footer should read "Authorized by NH Order No. 26,421 dated October 30, 2020 (interim rates) in Docket DG 20-152 and Order No. 26,419 dated October 30, 2020 (LDAC) in Docket No. DG 20-141."

Please refile the revised tariff pages per Puc 1603.03; Method of Filing. In accordance with the Secretarial letter issued March 17, 2020, this letter will be filed electronically only at this time.
