PETITION OF ATTORNEY ANDREW D. MYERS FOR INTERVENTION

Pursuant to the Order of Notice issued by the New Hampshire Public Utilities Commission in the above-captioned proceeding, N.H. Code Admin. Rules Puc 203.17, and RSA 541-A:32, Andrew D. Myers hereby petitions for leave to intervene in this matter.

In support thereof, Andrew D. Myers states as follows:

Rule Puc 203.17 provides that the Commission shall grant petitions to intervene in accordance with the standards of RSA 541-A:32. RSA 541-A:32, part of the Administrative Procedure Act, provides that a petition to intervene shall be granted upon a showing that the petitioner has “rights, duties, privileges, immunities or other substantial interests” that may be affected by the proceeding, and “the interests of justice and the orderly and prompt conduct of the proceedings would not be impaired by allowing the intervention.”

Andrew D. Myers personally is a residential ratepayer of said utility with a residential address of 6L Senter Cove Road, Derry, NH 03038, in what is called Pennichuck’s Farmstead District, and would be adversely affected by the said rate increase.

Moreover, Andrew D. Myers is also an attorney and represents the owners of twenty-one (21) other homes in the Farmstead District, including one state representative. Said homeowners

are residential customers of Pennichuck East Utility, Inc. and would be directly aggrieved by Pennichuck's Petition for a 21% permanent rate increase. All will have their rights and substantial interests affected by this case, and support this Petition for Intervention. See attached signature page.


WHEREFORE, Andrew D. Myers, Esq., respectfully requests that this Honorable Commission:
