Dear Attorney Sheehan:

On November 1 and November 2, 2023, Liberty filed a compliance tariff in all three of the above-captioned dockets. In its cover letter for all three dockets, Liberty represented that it had discovered an error in the model that generates its EV-L and EV-M rates, and that the error caused the rates to be significantly higher than they should be. Liberty further represented that it elected to file the incorrect rates on the grounds that they resulted from the model approved by the Commission in Order No. 26,604, and that it did not have authority to file any other rates. Liberty also stated that it would work with the New Hampshire Department of Energy to determine the best course of action to resolve the issue with the model. Finally, Liberty noted that these errors would not affect customers because there are no customers under the relevant EV-L and EV-M rates.

Based on Liberty's representations that the rates in its filing are inaccurate and need to be corrected, the compliance tariff filing in these three dockets is non-compliant.

In accordance with the Secretarial letter issued March 17, 2020, this letter will be filed electronically only at this time.
