Amended Procedural Schedule

To the Parties:

On June 30, 2021, Aquarion Water Company of New Hampshire, Inc. (Aquarion), with the assent of the parties, requested the Commission to amend the procedural schedule, which the Commission approved by secretarial letter dated March 24, 2021, as follows:

Technical Session/Settlement Conference (instead of August 19, 2021, at 9:00 a.m.)	August 16, 2021, at 9:00 a.m.
Technical Session Data Requests (instead of August 20, 2021)	August 17, 2021

Aquarion stated it had a conflict on August 19, which it could not resolve, so that these amendments to the procedural schedule would allow all parties to be available for the technical session/settlement conference and would not unduly delay this proceeding.

It has been determined that the proposed amended schedule is in the public interest and, therefore, it has been approved. The remainder of the previously approved procedural schedule shall remain in effect, with the following exception: the January 12, 2022 and April 13-14, 2022 hearings will start at 9:00 a.m.
