Staff has reviewed the tariff filing received on June 25, 2021 in the above-captioned proceeding. During review of the tariff filing, Staff noted that on the current tariff issued September 1, 2016 at Page 12, there is a rate category for 10 inch meter but in the tariff pages filed on June 25, 2021 and revised July 30, 2021, that category is not listed. Can you please provide a clarification why this category was not listed and what, if any, impact this will have on ratepayers?

It also was noted, that annotated tariff pages were not filed as specifically required pursuant to Order 26,488 dated June, 21, 2021.

Please refile the revised tariff pages per Puc 1603.03; Method of Filing.
