Chairman Goldner:

Pursuant to Order No. 26,790, Lakes Region Water Co., Inc., submits herewith its request for approval of rate case expenses and a calculation of reconciliation of temporary rates to permanent rates.

Lakes Region proposes a quarterly surcharge of \$15.50 for the recovery of \$56,702.18 over 2 quarters. In support of the Company's proposed surcharge, the Company is also providing the following schedules that show the calculations of the temporary/permanent rate reconciliation and rate case expenses (Bates Pgs. 002 & 003). The individual invoices are included to support the rate case expenditures requested for recovery pursuant to Puc 1905.02 (Bates Pgs. 004-157), together with a Motion for Confidential Treatment concerning legal invoices protected as confidential per RSA 91-A:5, XII.

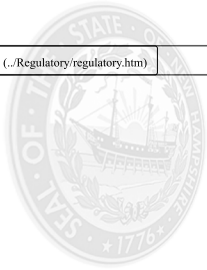
