Joint Petition to Approve Pole Asset Transfer

Procedural Order Re: Further Procedural Schedule and Record Requests

As indicated during the hearing held in the above-captioned matter on March 15, 2022, the procedural schedule in this matter has been expanded and amended as follows:

- 1) March 25, 2022 – responses to record requests due
- 2) April 1, 2022 – deadline to issue data requests on record request responses
- 3) April 15, 2022 – responses to data requests due
- 4) May 10, beginning at 9:00 a.m. – Hearing, continued for the limited issues of Public Service Company of New Hampshire d/b/a Eversource Energy’s revised proposed cost recovery proposal and the cross examination of New England Cable and Telecommunications Association, Inc.’s witness, Ms. Patricia Kravtin.
- 5) TBD – deadline for initial briefs
- 6) TBD – deadline for reply briefs

To the extent any existing procedural deadlines are inconsistent with the schedule entered above, they are superseded.

As indicated during the hearing held in the above-captioned matter on March 15, 2022, the Commission issued the following record requests to Public Service Company of New Hampshire d/b/a Eversource Energy:

1. Marked as Exhibit 68: For the time period January 1, 2021 through February 28, 2022, provide a record showing amounts billed from Eversource to Consolidated for vegetation management, or in the absence of a bill, the amount of any expenses that Eversource otherwise would have charged Consolidated.

2. Marked as Exhibit 69: Does Eversource have any other similar disputes over vegetation management expenses, either in New Hampshire or in other jurisdictions? If so, describe how Eversource addressed or is addressing such disputes.
3. Marked as Exhibit 70: Provide updated testimony and supporting exhibits, including Exhibit 7, reflecting Eversource's proposed revised cost recovery proposal that excludes capital costs. Include live Excel formats of all schedules and attachments.
4. Marked as Exhibit 71: Provide cash flow analysis or modeling performed by Eversource relating to the proposed transaction.

In addition, New England Cable and Telecommunications Association, Inc. was directed to file the rebuttal testimony of Ms. Patricia Kravtin, presented orally at hearing, in writing as Exhibit 72.
