Please refer to the tables below for all vegetation management costs that were billed/tracked by the Company as the responsibility of Consolidated for the period from 1/1/2018 through 2/28/2022. The first table provides the annual breakdown of the invoices billed/tracked for costs associated with the standard hazardous tree removal and maintenance tree trimming. The second table provides the annual breakdown of the invoices billed/tracked for costs associated with storm restoration and vegetation management efforts as a result of storm activity. Please note, as of the time of this submission the Company has final information through January 31, 2022.

Please also note that the Settlement Agreement between CCI and Eversource resolves the amounts through 2020. Therefore, the amount sought by the Company for recovery through the PPAM is \$9.4 million as of January 31, 2022 (\$8.3 million for 2021 and \$1.1 million for YTD 2022). This amount will increase with the passage of time. For storm-related vegetation management, the Company would include those costs in the future as incremental storm-related costs, just like any other incremental storm expense incurred by the Company in future storm proceedings, where applicable.
