Statements Regarding Applicant and its Principals

Regulatory Complaint Information

- 1. CleanChoice Energy, Inc. (f/k/a Ethical Electric, Inc.) in August 2016 signed an Assurance of Voluntary Compliance (IL AVC) in response to a request of the Illinois Attorney General. In the IL AVC, Ethical Electric, Inc. admitted no wrongdoing, but agreed to make changes to marketing and operational practice and procedures, to provide a credit of approximately \$10.00 to current and former customers, and to offer current and former customers the opportunity to request an additional refund if the customer felt misled by certain marketing claims.
- 2. CleanChoice Energy, Inc. (f/k/a Ethical Electric, Inc.) in May 2015 also signed an Assurance of Voluntary Compliance ("PA AVC") in response to a request of the Pennsylvania Attorney General. In the PA AVC, Ethical Electric admitted no wrongdoing, but agreed to make changes to marketing and operational practices and procedures. Ethical Electric paid no fines, nor paid any restitution to customers.
