In support of these tariffs, please find the rate development providing the calculation of the whole house residential time of use rates, initially filed as Revised Settlement Attachment 8. As shown, consistent with the Settlement Agreement approved in this proceeding, the rates for distribution, transmission and generation are derived from the ratios resulting from the initial peak, mid peak, and off-peak rates for the summer and winter seasons which were provided in DE 20-170 Exhibit 24 Revised, Attachment A Illustrative Rates.

These tariff pages are intended to revise the tariff pages filed on June 6, 2022 which included rates based upon Unitil’s proposed step adjustment in DE 22-026. The proposed step adjustment remains pending before the Commission as of this writing. As such, the Company is revising the tariff pages outlined above to exclude the step adjustment, and will make appropriate compliance tariff filings when it receives an order in DE 22-026. Tariff page 5-A is a new page summarizing the rates for the Company’s domestic whole house time of use
