Dear Mr. St. Cyr:

On March 22, 2021, Abenaki Water Company (the “Company”) filed a “Petition to Approve NH DWGTF Financing for Rosebrook Pressure Reduction Project”. In the Petition, the Company represented “[t]he DWG Trust Fund Administrator confirmed on 2/9/21 that funding of up to \$2,520,000 in loan funds and \$280,000 in grant funds would be available for the project. Subsequently, AWC is in the process of completing a final application for approval.” No further filings have been made indicating that final application has been completed or approval has been received. The Petition also indicated “The engineering including the plans and specifications and all AWC RB Fin 3 related information pertaining to the PRP must be complete and submitted to the Commission by August 2, 2021.” No plans and specifications have been received by the Commission.

The Commission requests that Abenaki Water Company file a status update letter in the above noted docket. In that letter, please include among other things, an update on the progress of the application and loan approval by the Department of Environmental Services. Please also include the information the Company indicated it would be providing on August 2, 2021, as well as a description of the improvements to be made to the Rosebrook system using the financing proceeds, a calculation of the rate impacts of the borrowing, and any other information relevant to the Commission’s review and approval of this financing request.
