Procedural Order Re: Witness Substitution


The Commission scheduled a continuation of the hearing in this matter on August 9, 2022. See Procedural Order dated July 15, 2022. On July 18, 2022, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a request to substitute Brian Morris for witness Kevin Boughan, who will be on vacation that week and unavailable to participate in the hearing. Eversource requested that Mr. Morris be permitted to appear remotely at the August 9 hearing, because he lives out of state.

To the extent that New Hampshire Code of Administrative Rules, Puc 203.07(e) provides 10 days for objections, it is hereby waived. Eversource's request to substitute Mr. Morris as a witness is granted, and his remote participation at the August 9 hearing is approved.


