To Commission Staff:

In accordance with the Commission's hearing guidelines issued for this docket on November 17, 2021, BCM Environmental and Land Law, PLLC, legal counsel for Wiggin Way/Winterberry Homeowners' Association, respectfully requests accommodations for a hybrid hearing to be offered for the February 23, 2022 Hearing on the Merits.

There are two reasons for this request. First, the Wiggin Way/Winterberry Homeowners' Association consists of 43 homes and 105 residents in Stratham. Many residents would like to attend the hearing, but with the current levels of Covid and the distance from Stratham to Concord, it would be challenging for them to do so. Second, I will be out of state on February 23, 2022, and unable to attend in person. This request is consistent with similar requests recently granted by the Commission. *See, e.g., Unitol Energy Systems, Inc., DE 21-030, Procedural Order (January 21, 2022).* Counsel for Aquarion Water Company, the Town of Hampton, and the Town of North Hampton do not object to the relief requested herein.
