On August 2, 2021, Northern Utilities, Inc. (“Northern” or the “Company”) submitted its filing in support of a request for a rate increase pursuant to N.H. Admin. Rules Puc 1600 *et seq.* Included with the filing were clean and redlined versions of Northern’s proposed temporary rates tariff page, Northern Utilities, Inc. Supplement No. 1 Original Page 1 (“Temporary Rates”). The clean and redlined versions submitted on August 2, 2021 contained an inadvertent clerical error: reference to “Rate Schedules (R-40, R-41, R-42, R-50, R-51 and R-52)” should instead be to “Rate Schedules (G-40, G-41, G-42, G-50, G-51 and G-52).” Northern now submits corrected clean and redlined versions of Northern Utilities, Inc.
