Dear Chair Goldner:

The Department of Energy (DOE) hereby submits the following specific comments regarding the Commission's Initial Proposal for adoption of the Chapter Puc 2200 Municipal and County Aggregation Rules:

- 1. Puc 2203.01(b). DOE questions whether the information should be posted on the DOE website instead of or in addition to the Commission's website.
- 2. Puc 2204.01(g). DOE believes that notice should be provided to DOE and the Office of the Consumer Advocate as well as to the Commission and the distribution utilities. Also, in the third line, the word "approval" should be changed to "approved" and a comma inserted after the word "rejected."
- 3. Puc 2204.03(a)(5). The language "any other information necessary for successful enrollment . . ." may be deemed overly broad and lacking in specificity; the Commission should consider using more limited and definitive language here.
- 4. Puc 2204.05(a). This section requires that DOE provide to the CPA information on establishing credentials to access the DOE's shopping comparison website "[w]ithin 10 days of receipt of a CPA's written notification of commencement of service . . ." DOE requests that the Commission change the applicable timeline to be "10 business days" rather than "10 days."
- 5. Puc 2205.02(a). The word "The" should be included before the reference to "Puc 2000 rules."

The DOE appreciates the opportunity to provide these written comments and respectfully requests that the Commission consider making changes to the Chapter Puc 2200 Municipal and County Aggregation Rules Final Proposal based on those comments.
