Re: North Northern Utilities, Inc. DG 21-144, Petition for Approval of Seventh Amendment to Special Contract-CONFIDENTIAL Updated Schedule NU-10

Dear Chairman Goldner:

On December 29, 2021, Northern Utilities, Inc. ("Northern" or the "Company") submitted a Petition for Approval of a Seventh Amendment to a Special Contract with Foss Manufacturing Company, LLC, now known as Foss Performance Materials, LLC ("Foss"). On February 23, 2022, the Commission ordered that an adjudicative proceeding be commenced for the purposes of reviewing the petition, and further ordered that Northern's Special Contract with Foss, as amended and approved by Order No. 26,107 (the "Sixth Amendment"), be extended for one year until February 28, 2023.

Commission Orders on prior extensions of the Special Contract have required that Northern provide the Commission with notice of impending adjustments to the special contract rates. *See* Docket DG 10-034, Order No. 25, 085 at 9 (Mar. 25, 2010) and Docket DG 12-031, Order No. 25, 330 at 6 (Feb. 6, 2012). Northern has provided such updates on an annual basis, Consistent with past practice, enclosed please find a confidential electronic copy and a redacted electronic copy of a document labeled "Updated Schedule NU-10". This document contains the calculations for the rates in effect from the period March 1 2022 through February 28, 2023. Please note that the confidential copy contains confidential information; it should be kept separate from the Commission's public document files and should not be posted on the Commission's electronic docket book files

This submittal updates the December 29, 2021 filing which was submitted with a



Motion for Protective Order that remains pending before the Commission. However, the Commission did grant the Company's Motion for Protective Order in connection with the Company's Marginal Cost Study submitted in support of the Sixth Amendment, which has been extended through February 23, 2023. This information is also being provided to Staff and the Office of Consumer Advocate with the understanding that it will be maintained confidential in accordance with the Commission's order granting the above-referenced Motion.

Pursuant to N.H. Admin. R. Puc 201.04 (C) (1) and (2), the enclosed document has been marked confidential in the upper right hand corner, and confidential information that has been redacted from the public versions of the documents has been designated in the enclosed documents by shading.

In accordance with the Commission's temporary moratorium on paper filings, the Company is submitting this filing only in electronic format.
