NOW COMES Paul J. Phillips, upon oath, being duly sworn, and states as follows:

- 1. I represent Kearsarge Telephone Company d/b/a TDS Telecom ("KTC"), in the above-captioned docket, which involves KTC's proposed modifications of certain service territory boundaries that it shares with Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications—NNE ("Consolidated") in the Town of Salisbury.
- 2. On April 1, 2022, the New Hampshire Public Utilities Commission ("the Commission") issued Order No. 26,602, an Order *Nisi* Approving Franchise Boundary Change (the "Order *Nisi*").
- 3. In the Order, the Commission directed KTC to take, *inter alia*, the following actions:
 - a. Cause a copy of the Order *Nisi* to be published in a newspaper of general circulation or of circulation in those portions of the State where the affected operations are conducted, such publication to be documented by affidavit filed with the Commission on or before April 27, 2022; and
 - b. Cause a copy of the Order *Nisi* to be delivered by first-class mail to each affected property owner and to the Town Clerk of Salisbury, New Hampshire, such delivery to be postmarked no later than April 6, 2022, and documented by affidavit filed with the Commission on or before April 27, 2022.
- 4. On behalf of KTC, I caused a copy of the Order *Nisi* to be published on April 11, 2022, in the *New Hampshire Union Leader*, a true and accurate copy of such publication being attached here as **EXHIBIT "A"**.
- 5. On behalf of KTC, I caused a copy of the Order *Nisi* to be mailed, by first class U.S. mail with a postmark date of April 6, 2022, to the Town Clerk of Salisbury, New Hampshire, and

to each location listed on Exhibit KTC-5 (List of Affected Addresses) to KTC's Petition in this proceeding, a true and accurate copy of the mailing to the Town Clerk being attached here as **EXHIBIT "B-1"**, and a true and accurate copy of the transmittal letter to one such location being attached here as **EXHIBIT "B-2"**.¹

6. The present Affidavit complies with the documentation requirements of the Order *Nisi*.



This order modifies a fran-chise boundary between Kearsarge Telephone Company (KTC) and Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications - NNE (Consolidated), to allow KTC to provide telephone and other services, including high-speed fiber-fed internet serv including ice, to 27 residential locations in the northeast corner of the Town of Salisbury (Salisbury). This order is issued on a nisi basis to ensure that interested persons receive notice and have the opportunity to comment or request a hearing before the order becomes effective.

I. PROCEDURAL HISTORY

On February 14, 2022, KTC filed a Petition to Modify Service Territory Boundaries in Salisbury. KTC also provided maps showing the proposed boundary modifica-

On March 24, 2022, at the request of the Commission, the New Hampshire Department of Energy (Energy) filed a memoran-dum, in which it recommended approval of the petition.

22-007.html. II. SUMMARY OF THE PETI-TION

KTC is an incumbent local exchange carrier (ILEC) operating as an excepted local exchange carrier (ELEC) with a service tentiory including most of Salisbury. Consolidated is an ILEC operating as an ELEC with a service territory including a por-tion of Salisbury not served by KTC. KTC represented that Consolidated supports the proposed boundary modification in Salisbury.

KTC wishes to expand its service territory to serve 27 customers located in part of the section of Salisbury in which Consolidated presently provides service as the ILEC out of the Franklin Telephone Exchange. KTC proposes to modify the existing service territory boundary between it and Consolidated so that the identified portion of Salisbury would be joined with the Salisbury Telephone Exchange.

KTC stated that it would become the ILEC in those areas but Consolidated would continue to maintain its facilities and would be able to provide service to any customer that desired to receive service from Consolidated. KTC noted that it is an established ILEC in the area, having served customers in Salisbury since 1899. KTC proposed that the Commission grant its petition subject to certain conditions. Those conditions include: "that KTC will cause a copy of the Commission's approval order to be: (a) published once in a statewide newspaper of general circulation or of circulation in those portions of the State where the affected operations are con-ducted; (b) delivered to the Town Clerk of the Town of Salisbury; and (c) delivered to all customers located in the new franchise territory; such publication and service to be accomplished no later than fourteen [14] days from the date of the Commission's approval order and to be documented by affidavit filed with the Commission no later than fourteen (14) days from the date of publication and service" and that the Commission provide an opportunity for interested persons to provide comments on an approval order. Petition at 4.

III. DEPARTMENT OF ENERGY RECOMMENDATION

Energy stated that its staff reviewed KTC's petition and supporting documentation and conducted informal discovery with KTC and Consolidated. Energy determined that the request was based on Salisbury's request for KTC to extend its fiber optic service, including high-speed fiber-fed internet service, to the 27 homes that are the subject of the petition.

According to Energy, the 27 customers affected by the proposed boundary modification could remain with Consolidated or take service from KTC, and that any customer choosing KTC voice service would need to change their landline telephone number. Energy stated that it had determined that KTC has the technical, managerial, and financial expertise necessary to carry out the obligations of an ILEC as described in RSA 362:8 and RSA 374:22-p and recommended that the Commission grant KTC's petition.

IV. COMMISSION ANALYSIS

The relevant statutory criteria for approval of the transfer of a portion of an ILEC's service territory is set forth in RSA 374:30, II. The Commission must approve such a transfer if it finds that the transferee utility will maintain the technical, managerial, and financial capability to perform the obligations of an ILEC as set forth in RSA 362:8 and RSA 374:22-p. See RSA 374:30, II. The applicable standard focuses not on general end user services, but on basic service and wholesale services provided by the ILEC, and the

technical, managerial, and financial capability to continue to provide those services following the transfer. See Dunbarton Telephone Company, Inc., Order No. 26,380 (July 13, 2020). We note that KTC is a long-

standing ILEC, now operating as an ELEC, in New Hampshire. See. e.g., Kearsarge Telephone Co.. Wilton Telephone Co., Hollis Telephone Co. and Merrimack County Telephone Co., Order No 25,182 at 27 30 (December 22, 2010). We also note the Department of Energy's determination that KTC has the technical, managerial, and financial expertise necessary to carry out the obligations of an ILEC. Based on that history, we find that KTC is technically. managerially, and financially capable of maintaining the obligations of an ILEC as required by RSA 374:30. II. We therefore approve KTC's petition, on a nisi basis, so that interested persons receive notice and have the opportunity to comment or request a hearing before the order becomes effective.

In addition to incorporating KTC's proposed conditions into our order, we also will require that revised franchise maps be filed with the Commission, as a compli-

ance filing in this docket.

Based upon the foregoing, it is hereby

ORDERED NISI, that, subject to the effective date below, the petition of Kearsarge Telephone Company to modify its service territory boundary in Salisbury, New Hampshire, is GRANTED; and

FURTHER ORDERED, that Kearsarge Telephone Company shall cause a copy of this order nisi to be published newspaper of general circulation or of circulageneral circulation of of circula-tion in those portions of the State where the affected operations are conducted, such publication to be documented by affidavit filed with the Commission on or before April 27, 2022; and it is

FURTHER ORDERED, that Kearsarge Telephone Company shall cause a copy of this order nist to be delivered by first class mail to each affected property owner and to the Town Clerk of Salisbury. New Hampshire. such delivery to be postmarked no later than April 6, 2022, and documented by affidavit filed with the Commission on or before April 27. 2022; and it is

FURTHER ORDERED, that persons interested in responding to this order nisi be notified that they may submit their comments or file a written request for a hearing that states the reason and basis for a hearing no later than April 18, 2022, for the Commis-sion's consideration; and it is FURTHER ORDERED, that

persons interested in responding to such comments or request for hearing shall do so no later than April 25, 2022; and it is

FURTHER ORDERED, that this order nisi shall be effective on

May 2, 2022, unless Kearsarge Telephone Company fails to satisfy the publication and delivery obligations set forth above or the Commission provides otherwise in a supplemental order issued prior to the effective date; and it is

FURTHER ORDERED, that Kearsarge Telephone Company shall electronically file into this docket copies of the relevant franchise maps no later than 15 days from the effective date of the
