The Department of Energy (DOE) has reviewed and analyzed the *Calendar Year 2021 Storm Fund Report* ("2021 Report") filed by Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty ("Liberty" or "the Company") on April 1, 2022 and the DOE Enforcement Division's *Final Audit Report* (dated September 9, 2022).

Enclosed please find DOE's recommendation and supporting technical statement (audit attached). The technical statement summarizes DOE's review, analysis, conclusions and recommendations with respect to Liberty's 2021 Report. DOE supports allowance of the audit adjusted amount identified in the technical statement of \$695,673 for 2021 storm related pre-staging costs as eligible for collection through the Company's Major Storm Fund account. *See DOE Technical Statement* at 3 and Attachment 1 (*Final Audit Report*) at 20.

The Company agrees with the adjustments identified in the *Final Audit Report*. *See DOE Technical Statement*, Attachment 1 at 21-23. Therefore, DOE further recommends that the Commission approve the audit adjusted amount identified above without a hearing and without any further process before the Commission. In that event, Docket No. DE 22-019 may be closed.

Please note, it is unusual that a DOE *Recommendation and Supporting Technical Statement* is issued one business day after the *Final Audit Report* itself. DOE extended itself to avoid seeking an enlargement of time in this docket; in addition, audit issues were minimal.
