Dear Mr. Hall:

Reference is made to Liberty's compliance tariff filing made in the above-captioned docket on September 15, 2022, pursuant to the terms of Order No. 26,676 (August 31, 2022).

Employees of the New Hampshire Public Utilities Commission have reviewed this Tariff filing, and associated schedules and workpapers. Upon review, it has been noted that Liberty has supplied workpapers, in the form of Excel schedules, that continue to use hard-coded figures instead of live-modelling figures, in contravention to the directives presented in Order No. 26,676. Ref. Att-ELM-1, Page 3. This Att-ELM-1, Page 3 schedule also presents figures based on Liberty's proposed revenue requirement figure for its Step Adjustment of \$2,539,784, instead of the revenue requirement figure of \$2,066,083 approved by the Commission in Order No. 26,676. Ref. Order No. 26,676 at Page 7. The Commission will therefore approve Liberty's compliance tariff filing made in this docket on a provisional basis, pending proper submission by Liberty of Att-ELM-1 meeting these parameters. At such time that this issue is resolved, the Commission will conduct a review and confirm the permanent rates in effect.

A copy of this letter is being entered into the docket and the tariff filing will be placed in our permanent file. A date stamped copy of the filed Tariff pages is enclosed for your files.
