Dear Chairman Goldner:

On Friday, May 12, 2023, the Commission directed Pennichuck Water Works, Inc. ("PWW"or "the Company") to file Attachment A and Attachment C- H in live Excel format by May 16, 2023. See Commission's Procedural Order (May 12, 2023).

Attachment A was created by the New Hampshire Department of Energy ("Department" or "DOE"). Due to staff availability on May 12, the Department was not able to file Attachment A *in live Excel format* until today. The Department notes for the record that PWW already filed Attachment A in this docket, in PDF format, when PWW filed the proposed settlement agreement. See Exhibit 5. The live Excel format is incompatible with the virtual docket. Accordingly, the undersigned shall provide the Attachment A in live Excel format to the Commission and parties by a separate email on or before the close of business today, contemporaneously with this filing.

The Department is aware of other Excel spreadsheets in the attachments the Settling Parties have jointly filed. Specifically, PWW's responses to DOE's data requests 2-33, 3-3, 5-10 and 5-12 in Attachment B contain *ancillary* spreadsheets. The Department stresses that the spreadsheets are ancillary. Out of an abundance of caution, however, and to avoid a further continuance, the Department identifies them here. Should the Commission wish to review live Excel versions of all spreadsheets, time remains for the Commission to so inform the parties.
