Dear Attorney Brown:

Employees of the Public Utilities Commission have reviewed the tariff filing received on August 28, 2023 in the above-captioned proceeding. Supplement No. 6 has an effective date of August 28, 2023, which is the same day that it was filed. This is inconsistent with New Hampshire Code of Administrative Rules, Puc 1603.07, which requires that utilities notify the commission of proposed tariff changes at least thirty days before the change is to become effective. Further, Supplement No. 6 does not contain a complete authorization footnote per Puc 1603.06(m)(1) and (o). For these reasons, these pages are not compliant with the Puc 1600 rules. The Commission appreciates that Pennichuck Water Works, Inc. (PWW) filed these pages together with its motion to recover its rate case expenses in accordance with Puc 1603.05. PWW need not refile Supplement No. 6 until the Commission directs it to do so.

In accordance with the Secretarial letter issued March 17, 2020, this letter will be filed electronically only at this time.
