**Request for Change in Rates**

**Procedural Order Re: Motion to Reschedule**

The Commission issued an order on July 26, 2022 suspending proposed tariffs, commencing an adjudicative proceeding, and scheduling a prehearing conference and technical session on August 24, 2022. *See* Order No. 26,652. Order No. 26,652 required Pennichuck Water Works, Inc. (PWW) to provide notice by publication in a newspaper no later than August 8, 2022 and to file an affidavit of publication by August 12, 2022.

On July 28, 2022, PWW filed a motion to reschedule the prehearing conference and technical session, as well as to extend the August 8 and August 12 deadlines. PWW requested that the prehearing conference and technical session be rescheduled, because its chief executive officer is not available on August 24. In addition, PWW stated that it would be required to submit a copy of the order to the newspaper by August 4, 2022 in order for publication to take place by the August 8 deadline. PWW requested that the August 8 and 12 deadlines be extended, because it was unable to obtain the New Hampshire Department of Energy's (DOE) position on its motion, and the 10-day period for the DOE to respond would end on August 8.

To the extent that New Hampshire Code of Administrative Rules, Puc 203.07(e) provides 10 days for objections, it is hereby waived. PWW's motion to reschedule the August 24 prehearing conference and technical session is GRANTED, and the prehearing conference and technical session are rescheduled to Wednesday, September 7, 2022, at 1:30 p.m. It is suggested that counsel notify the Clerk's Office if

it wishes certain dates to be avoided when there are matters to be scheduled in the future. As sufficient time remains for PWW to meet the deadlines for publication of notice and filing its affidavit of notice, PWW's request to extend these deadlines is DENIED.
