Request for Step Adjustment

Procedural Order Re: Technical Session

On July 14, 2023, the Commission issued a set of record requests to Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty) and the New Hampshire Department of Energy. On July 20, 2023, both entities filed responses to the Commission's requests that did not entirely resolve the Commission's questions regarding Liberty's EV-L and EV-M rates. To resolve the ongoing issues with these rates, the Commission will schedule a public technical session with Liberty and any other interested parties for August 16, 2023 at 10:00 a.m.


The Commission requests that Liberty be prepared to verify that the data inputs conform to the terms of the Settlement Agreement in Docket No. DE 19-064, including by presenting the soft versions of the inputs at the technical session.

After the technical session, the Commission staff in attendance will prepare a report on the discussion of issues related to Liberty's EV-L and EV-M rates in its current tariff. The Commission shall thereafter issue an order on tariff compliance as relates to the EV-L and EV-M rates.
