Procedural Order Re: Request to Extend Deadlines

On September 8, 2023, the New Hampshire Department of Energy (DOE), on behalf of all the parties in the above-captioned docket, filed a request to extend the deadlines contained in the Commission's August 22, 2023 prehearing order. The August 22 order required the parties to file a proposed procedural schedule by September 8, 2023 and allowed the parties and interested persons to submit filings regarding the scope of this proceeding by September 15, 2023. The parties requested that the Commission extend both deadlines to September 22, 2023, pursuant to New Hampshire Code of Administrative Rules, Puc 202.04, because they stated that they needed additional time to draft scoping comments and to develop a procedural schedule, tasks that they maintained are interrelated.

The DOE's request for an extension is GRANTED. The parties shall file a proposed procedural schedule on or before September 22, 2023. The parties and any interested persons may submit responsive filings regarding the scoping matters discussed in the August 22 prehearing order on or before September 22, 2023.
