**Procedural Order Re: Joint Request for Additional Time**

On January 16, 2024, the New Hampshire Department of Energy (DOE) filed a request, joined by the other parties in the above-captioned docket, for additional time. In the joint request, the DOE stated that Roger Colton is no longer available as a witness in February 2024, and the parties are working on a new procedural schedule, which they anticipate filing by February 1, 2024.

The Commission GRANTS the parties' joint request. The hearing currently scheduled for February 21, 2024 is CANCELLED, and the parties shall file a proposed revised procedural schedule, that includes three dates on which all parties are available for a hearing, on or before February 1, 2024. The Commission anticipates that the rescheduled hearing will be in early April 2024.
