On January 31, 2023, the Commission issued a procedural order directing Liberty to refile final versions of all pending tariff pages in this docket to replace all previous filings of the pending tariff pages. On February 7, 2023, Liberty submitted the above-referenced tariff pages pursuant to that procedural order.

Employees of the New Hampshire Public Utilities Commission have reviewed the tariff filings received on February 7, 2023 in this proceeding.
