## Dear Chairman Goldner:

The Department of Energy (DOE or "the Department") respectfully requests a change in the approved procedural schedule to extend deadlines in this docket by approximately one month. This request will require a new hearing date as well.

The Office of the Consumer Advocate (OCA) and Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty ("Liberty" or "the Company") assented to the relief requested in principle on or about April 7. Developing a specific schedule required additional time. OCA and Liberty assented to the specific schedule set forth below on April 18 and April 26, respectively.

This change is sought because the Department's work on the "old RDAF" docket, Docket No. DG 22-041, took substantially more time than anticipated. OCA and Liberty are also parties in the "Old RDAF" docket. That focus took time away from work required in Docket No. 22-045, the docket at issue here, addressing "new RDAF" and the gasholder.
