### **REQUEST:**

Reference: COG filing (September 2, 2022), Testimony of Heather Tebbetts, Bates Page 010-11, Testimony of Debra Gilbertson

Please provide a copy of all fixed-price-offer (FPO) letters (for both the EnergyNorth and for the Liberty-Keene division) sent to customers to alert them to Liberty's FPO offer. If the Company's letters do not identify a "start" and "end" date within which time a customer may elect FPO rates, please identify those periods.

- A) What percentage of customers accepted the FPO offer in the 2021-2022 (Winter) season?
- B) How many customers have already accepted the Company's FPO offer for the Winter 2022-23, to date, for EnergyNorth and Liberty-Keene respectively?
- C) With reference to the chart on Bates page 011 that compares the anticipated FPO Bill impact for Winter 2022/23, please explain why there is an impact, and why the impact differs between FPO and Non-FPO customers. For example, is the impact based on the loss of revenue the Company experiences if FPO customers pay less, distributed between both categories of customers? In the alternative, if the FPO customers pay more than Non-FPO customers, would that reduce the customer's bill impact for Non-FPO customers? Please identify all the reasons the Company is aware of for the different bill impacts.
  - Please create a similar chart for low-income Residential customers (Residential R-4) for 2022/23.
- D) Please create a similar chart for Residential R3 and R4 customers using Winter 2021-2022 data.
- E) Does FPO actual revenue offset RDAF allowed revenue?

## **RESPONSE:**

See Attachment DOE 2-7 for draft copies of the FPO letters. The Company plans to mail them on September 20, 2022.

- A) For ENNG, 10.2% of the Company's customers took the FPO option for the 2021/2022 winter season. For Keene, 1.5% of customers took the FPO option for the same period.
- B) As of the date of this response, the letters have not been mailed so no customers have enrolled yet.
- C) The impact for FPO and non-FPO rates compare Winter 2021/2022 to Winter 2022/2023. The requested FPO and non-FPO rates for Winter 2022/2023 are higher than the requested rate from Winter 2021/2022. The impact is not related to any loss of revenue. The FPO rate is \$0.020 more per therm per Order No. 24,515 and provides that the revenues from the premium are credited to the COG, which reduces the risk of the non-FPO participants subsidizing the FPO customers and replace the margins which were previously credited to the COG and not to the FPO.
  - Please see Bates 093 for a detailed comparison of Winter 2022/2023 to Winter 2021/2022 for rate R-4. The cost of gas for Winter 2021/2022 was \$287.16 versus \$591.82 for the cost of gas for Winter 2022/2023. The impact is \$304.66 more for Winter 2022/2023 than Winter 2021/2022.
- D) Please see Bates 091 for non-FPO R-3, Bates 092 for FPO for R-3 and R-4, and Bates 093 for non-FPO for R-4.
- E) The RDAF is not associated with the COG, only distribution, and the FPO only offsets COG revenues.
