Re: DT 22-047 Charter Communications, Inc., Cogeco US Finance, LLC d/b/a Breezeline, and Comcast Cable Communications, LLC v. Consolidated Communications of Northern New England Company, LLC – Petition for Resolution of Rate Dispute

Dear Chairman Goldner:

In accordance with discussions at the prehearing conference and technical session held November 1, 2022 in the above-captioned docket, the undersigned and representatives of Consolidated and the New Hampshire Department of Energy (“DOE”) met via videoconference this morning for the purpose of attempting to develop a mutually agreeable procedural schedule for this docket. Although the parties discussed Consolidated’s and the Petitioners’ preferred schedules, no agreement was reached by the parties during that meeting. After the meeting, the undersigned revised the Petitioners’ initially proposed schedule and provided the revised schedule (set forth below) to Consolidated and DOE. As of the time of this filing, the parties have not reached agreement on a procedural schedule.

In view of the foregoing, the Petitioners respectfully submit the procedural schedule set forth below for the Commission’s consideration. The schedule achieves the goal of allowing the Commission to meet its deadline under 42 U.S.C. § 224(c)(3)(B) for issuing an order on the merits, and also preserves the parties’ procedural rights to conduct discovery, and the Petitioners’ right to file written rebuttal testimony.
