**P R O C E E D I N G**

CHAIRMAN GOLDNER: Okay. We're here this afternoon for a public comment hearing on the Puc Part 206 Rules, the Procedures and Standards for Alternative Forms of Regulation. The Commission intends to readopt this part of the Chapter 200 rules without amendment.

Has everyone had an opportunity to sign in on the sign-in sheet?

CHAIRMAN GOLDNER: I think so, counting four.

So, okay. I have only one on the sign-in sheet, Mr. Wiesner. Is that correct? Did anyone else want to speak?

CHAIRMAN GOLDNER: No.

MR. WIESNER: I'm happy to go first.

CHAIRMAN GOLDNER: Thank you.

MR. WIESNER: And perhaps last as well.

CHAIRMAN GOLDNER: I think that would be perfect.

1                   MR. WIESNER: Thank you, Mr. Chairman.  
2                   David Wiesner, representing Public Service  
3                   Company of New Hampshire, doing business as  
4                   Eversource Energy.

5                   I just came this afternoon to say that  
6                   we have no objection to readoption of Part 206.

7                   I will note, for the record, that last  
8                   fall the joint utilities filed comments on the  
9                   200 rules as a whole. And there were two minor  
10                  changes that we proposed be made to this  
11                  section -- this part, rather. And I assume that  
12                  the Commission may make those changes when a more  
13                  comprehensive set of amendments is proposed,  
14                  hopefully, later this year.

15                  CHAIRMAN GOLDNER: Thank you, Mr.  
16                  Wiesner.

17                  Would anyone else like to comment?

18                  *[No verbal response.]*

19                  CHAIRMAN GOLDNER: Second chance?

20                  *[No verbal response.]*

21                  CHAIRMAN GOLDNER: Okay. All right.  
22                  Anything else, Mr. Wiesner?
