**Consideration of Changes to the Current Net Metering Tariff Structure, Including  
Compensation of Customer-Generators**

**Prehearing Order**

**ORDER NO. 26,769**

**February 1, 2023**

**I. PROCEDURAL HISTORY**

Pursuant to an order commencing an adjudicative proceeding (Initial Order) issued on September 20, 2022, the Commission held a prehearing conference on January 5, 2023. The Initial Order designated the three regulated New Hampshire electric distribution utilities operating in New Hampshire, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource), Unitil Energy Systems, Inc. (Unitil), and Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty), as mandatory parties to the docket. The Office of Consumer Advocate (OCA) filed a letter indicating its participation in this docket on September 21, 2022. On October 31, 2022, the New Hampshire Department of Energy (DOE) filed a Final Report of Dunskey Energy Consulting on the Value of Distributed Energy Resources (VDER) Study.

## **II. INTERVENTION REQUESTS**

The standard for intervention is found at N.H. Code of Admin. R. Puc 203.17, which incorporates the standard found in, RSA 541-A:32. Under RSA 541-A:32, there are two standards for ruling on petitions for intervention, mandatory and permissive. We will review the pending intervention requests under the mandatory intervention standard which requires:

1. timeliness;
2. a sufficient showing that the petitioner has rights, duties, privileges, immunities or other substantial interests that may be affected by the proceeding or is entitled to intervene by law; and
3. granting intervention will not impair the interests of justice or the orderly and prompt conduct of the proceeding.

Each of the nine parties seeking intervention, listed above, are either ratepayers, potential ratepayers, or organizations with members comprising these groups. As a result, we find that they meet the mandatory test for intervention and we grant them party status in this docket. In order to promote the orderly and prompt conduct of this proceeding, we ask that the intervenors attempt wherever possible to combine and submit joint testimony, comments and discovery.

## **III. ADMINISTRATIVE NOTICE**

On August 21, 2020, the Commission Staff (now DOE staff) filed the Locational Value of Distributed Generation (LVDG) Study in Docket No. DE 16-576. The Initial Order stated that the Commission intended to take administrative notice of the LVDG Study, pursuant to New Hampshire Code of Administrative Rules, Puc 203.27. The Initial Order provided that any party objecting to administrative notice of the LVDG Study could do so pursuant to Puc 203.27(c) by filing a written objection on or before the prehearing conference. No party filed a written objection and no party objected at

the prehearing conference. Accordingly, the Commission takes administrative notice in this docket of the LVDG Study filed in Docket No. DE 16-576.

#### **IV. PROCEDURAL SCHEDULE**

On January 19, 2023, Liberty Utilities, Inc. filed a recommended procedural schedule agreed upon by the following parties: the DOE, the OCA, Conservation Law Foundation, Clean Energy NH, Walmart, IBEW Local 490, Colonial Power Group, Granite State Hydropower, Consumer Energy Alliance, Community Power Coalition of NH, Eversource, Unitil, and Liberty. According to Liberty, no party objected to the proposed schedule.




