**Procedural Order Re: CLF and Mr. Terry Clark Petitions for Intervention**




On December 1, 2022, Conservation Law Foundation (CLF) filed a timely petition to intervene in this docket. CLF did not indicate, in its December 1, 2022, filing, the positions of other parties to this proceeding regarding its petition. At the December 13, 2022, prehearing conference for this proceeding, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty), the New Hampshire Department of Energy (DOE), and the Office of the Consumer Advocate (OCA), stated that they had no objections to CLF's petition to intervene. (No written objections to CLF's petition to intervene were filed).

On December 2, 2022, Mr. Terry Clark, by his attorney, Richard Husband, Esq., filed a timely petition to intervene in this docket. Mr. Clark did not indicate, in his December 2, 2022, filing, the positions of other parties to this proceeding regarding his petition. At the December 13, 2022, prehearing conference, Liberty, the DOE, and the OCA stated that they had no objections to Mr. Clark's petition to intervene. (No written objections to Mr. Clark's petition to intervene were filed).

Having reviewed the petitions to intervene and considered the oral arguments made by CLF and on behalf of Mr. Clark in support of their petitions at the December 13, 2022, prehearing conference, the Commission has GRANTED CLF's and Mr. Clark's requests to intervene, finding that the standard for discretionary intervention in RSA 541-A:32, II has been met for these intervenors individually, insofar as the intervention of CLF and Mr.

Clark would be in the interests of justice and would not impair the orderly and prompt conduct of the proceedings. *See* N.H. Admin. R., Puc 203.17.
