Complaint by Residents of Colonial Drive, Moultonborough against Agape Community Church Sewer System

Prehearing Order

April 26, 2023

In this proceeding, the residents of Colonial Drive in Moultonborough, NH, seek resolution of a complaint made against Agape Community Church regarding sewer system operation and maintenance. A prehearing conference on this matter was held on April 5, 2023. This order memorializes Commission rulings made at that prehearing conference.

I. Intervention Request

On March 30, 2023, Lamprey Suburban Septic, Inc. (Lamprey Septic) filed a petition to intervene in this proceeding. We have received no objections to this petition for intervention. The Commission grants Lamprey Septic's intervention request pursuant to N.H. Code of Admin. R. Puc 203.17 and the standard set forth under RSA 541-A:32,II. We find that Lamprey Septic's intervention and participation in this proceeding is in the interests of justice and would not impair the orderly and prompt conduct of the proceedings.

II. Preliminary Procedural Schedule

Participants in the prehearing conference agreed to a deadline of April 26, 2023, for the submission of legal briefs on issues raised in this proceeding. The parties are encouraged to brief the preliminary issues set forth in Section II of the Commission's Commencement of Adjudicative Proceeding and Notice of Prehearing Conference order

issued in this docket on February 1, 2023. In developing their briefs, parties are further encouraged to review relevant documentation from municipal and state entities regarding approvals and/or permissions for the installation of a sewer system as part of the Colonial Drive subdivision. To the extent additional time may be required to address the above-noted issues, given the issue date of this order, parties may submit supplemental briefing by Friday, April 28, 2023.
