A prehearing conference and subsequent technical session were held in the abovecaptioned docket on March 21, 2023. The Department of Energy (DOE or Department), Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty), NRG Retail Companies, Inc. (NRG), and the Community Power Coalition of New Hampshire (CPCNH) (hereinafter "The Parties") met during the technical session to discuss procedural schedules.
