Re: DE 23-003, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Proposed Purchase of Receivables Program; Parties' Revised Proposed Procedural Schedule

Dear Chairman Goldner:

On July 19, 2023, the parties to this docket, the Department of Energy (DOE or Department), Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty), NRG Retail Companies (NRG), and the Community Power Coalition of New Hampshire (CPCNH) (hereinafter "The Parties"), filed a joint motion to stay proceedings in the above-captioned docket pending further joint settlement discussions. The Commission granted the motion to stay in a July 20, 2023, procedural order, and requested that the parties file a revised proposed procedural schedule by August 1, 2023.

In the July 20, 2023, procedural order, the Commission also granted the parties' request to keep both of the currently scheduled August 22, 2023, and September 19, 2023 hearing dates. As part of the revised proposed procedural schedule, the parties request that the Commission cancel the August 22, 2023, hearing date and retain the September 19, 2023, hearing date. The parties have also included a revised settlement filing deadline of September 5, 2023, per the Commission's request in the July 20, 2023, procedural order to set a settlement filing deadline no later than ten business days before the final hearing.

Per the Commission's July 20, 2023, procedural order, below is the parties' joint proposed updated procedural schedule.
