# PUBLIC SERVICE COMPANY OF NEW HAMPSHIRE d/b/a EVERSOURCE ENERGY Proposed Purchase of Receivables Program

### SUPPLEMENTAL ORDER OF NOTICE

On September 13, 2023, Public Service Company of New Hampshire d/b/a
Eversource Energy (Eversource), on behalf of the other parties to this docket,¹ filed a
settlement agreement (Settlement Agreement) on the general terms of Eversource's
proposed purchase of receivables (POR) program. One term of the Settlement
Agreement included requesting that the Commission notice a supplemental phase of
this proceeding to consider changes to Eversource's Tariff NHPUC No. 10 – Electricity
and Electric Supplier Services Master Agreement necessary to implement the proposed
POR program. Under the Settlement Agreement, the proposed POR program will not go
into effect until the Commission approves the necessary revisions to the supplier
agreement and tariff.

The Commission denied the Settlement Agreement, but approved parts of the POR program described therein, and continued this proceeding to a second phase to further develop inputs in the calculation of discount percentage rate of the POR program, and to address necessary revisions to Eversource's Tariff NHPUC No. 10 – Electricity and Electric Supplier Services Master Agreement. presented in this proceeding: the consideration of revisions to Eversource's Tariff

Eversource has not filed proposed revisions to these documents with the Commission.

### Based upon the foregoing, it is hereby

**ORDERED**, that any entity or individual may petition to intervene and seek to be admitted as a party in this proceeding. Each party has the right to have an attorney represent the party at the party's own expense; and it is

**FURTHER ORDERED**, that, consistent with N.H. Admin. R., Puc 203.17 and Puc 203.02, any entity or individual seeking to intervene in the proceeding shall file with the Commission a petition to intervene with copies sent to Eversource and any other parties on the service list, on or before ADMIN INSERT DATE. The petition shall state the facts demonstrating how the petitioner's rights, duties, privileges, immunities, or other substantial interests may be affected by the proceeding, consistent with N.H. Admin. R., Puc 203.17; and it is

**FURTHER ORDERED**, that any party objecting to a petition to intervene make said objection on or before ADMIN INSERT DATE; and it is

**FURTHER ORDERED**, that the parties file a procedural schedule to adjudicate the issues outlined in Order No. xx,xxx (ADMIN INSERT DATE) and this supplemental order of notice by ADMIN INSERT DATE; and it is

**FURTHER ORDERED**, that parties shall file any proposed exhibits, written testimony, motions, or other documents intended to become part of the record in this

proceeding with the Commission. Pursuant to the secretarial letter issued on March 17, 2020, which is posted on the Commission's website at

https://www.puc.nh.gov/Regulatory/Secretarial%20Letters/20200317-SecLtr-Temp-Changes-in-Filing-Requirements.pdf, all Commission rules requiring the filing of paper copies are suspended until further notice. Parties may elect to submit any filing in electronic form unless otherwise ordered by the Commission. Filings will be considered filed as of the time the electronic copy is received by the Commission; and it is

**FURTHER ORDERED**, that routine procedural inquiries may be made by contacting the Commission's Clerk's Office at (603) 271-2431 or <a href="ClerksOffice@puc.nh.gov">ClerksOffice@puc.nh.gov</a>. All requests to the Commission should be made in a written pleading filed with the Commission. Unless otherwise authorized by law, *ex parte* communications are prohibited; and it is

**FURTHER ORDERED**, that pursuant to N.H. Admin. R., Puc 203.12, Eversource shall notify all entities and individuals by publishing a copy of this order of notice on its website no later than two business days after the date of issue, such publication to be documented by affidavit filed with the Commission on or before ADMIN INSERT DATE. In addition, the Clerk shall publish this order of notice on the Commission's website no later than two business days after the date of issue; and it is

**FURTHER ORDERED,** that any hearings in this matter shall be conducted in accordance with the hearing guidelines issued in this docket.
