Response to May 15, 2023, Tariff Compliance Letter

Dear Chairman Goldner:

In response to the letter filed on May 15, 2023, on behalf of Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty, the Company provides the following information in one filing with an over-arching cover letter summarizing and mapping each change to facilitate the Commission's review of the above-mentioned tariff compliance filings, as requested by the Tariff Administrator.

#### Docket No. DE 20-170 EV-Time-of-Use Rates

For both the July 10, 2022, and November 1, 2022, filings, the Company was requested to provide the following:

- (i) associated EV-L and EV-M rate design models;
- (ii) summary tables linking and sourcing the input for the G-1 and G-2 revenues used in the EV-L and EV-M models; and
- (iii) a written explanation that points to the exact tab/row/column to refer to in the source spreadsheets.

July 10, 2022, Rates

The rates effective July 10, 2022, were approved in Order No. 26,537 dated October 29, 2021. In that Order, the Commission approved \$1,232,187 of investment costs associated with the battery storage pilot. During the subsequent audit, \$46,062 was found to be Contributions in Aid of Construction ("CIAC"), and \$599,510 was attributable to Cost of Removal inadvertently included in the original filing on April 6, 2021. Given these audit findings, the calculation of the total to be allowed for recovery was \$586,615, (\$1,232,187 - \$46,062 - \$599,510 = \$586,615), and as such those amounts were removed from the total amount to be included in rates for November 1, 2021. The final approved revenue requirement of \$94,064, is shown in Attachment DE 19-064 rev req Order No. 26,537.xlsx, tab rev req Line No. 1. There was no distribution rate change between November 1, 2021, and July 10, 2022.

# November 1, 2022, Rates

For transmission and energy service rates, the Bates pages to each filing are also listed in the table below.

The November 1, 2022, filing was a seasonal change and therefore the rate change did not incorporate new data, it merely included the winter rates from tab TOU Rate Summary (Testimony). As noted in the Company's response to the May 15, 2023, letter in Docket No. DE 22-035, Second Revised Tariff Page 128 has been corrected due to the numbers used to calculate the distribution rates being incorrect in the model. Second Revised Tariff Page 128 and Fifteenth Revised Tariff Page 127 is provided with the correct value for the distribution TOU rates in the Company's November 1, 2022, compliance tariff filing.

## Docket No. DE 22-035 Request for Step Adjustment

For the August 1, 2022, filing, the Company was requested to provide the following:

(i) summary tables linking and sourcing the input for the G-1 and G-2 revenues used in the EV-L and EV-M models; and

(ii) a written explanation that points to the exact tab/row/column to refer to in the source spreadsheets.

In response to the letter filed on May 15, 2023, the Company provides the following information as requested by the letter.

- (i) a summary table correctly linking and sourcing the input for the G-1 and G-2 revenues used in the associated EV-L and EV-M models; and
- (ii) a written explanation that points to the exact tab/row/column to refer to in the source spreadsheets.

The table below provides the references that may be found in the models. This rate change affected distribution rates only. In reviewing the model data, attachments 22-035\_2023-04-13\_Liberty Model\_tariff EV-L rev\_eff. 2022-08-01 rev 5-16-2023.xlsx, and 22-035\_2023-04-13\_Liberty Model\_tariff EV-M rev\_eff. 2022-08-01.xlsx, the PUC should tie the numbers in the tab Liberty Distribution Revenues in each model to the following tabs and cells listed in the table below.

Liberty has enclosed the attachments listed below associated with its April 13, 2023, filing. When reviewing the model data for the August 1, 2022, change, the reviewer will see in comparison to the July 10, 2022, model data the off-peak kilowatt-hours and the credit for high voltage from the kWh line on tab Liberty Distribution Revenues were omitted in the July 10, 2022, rates calculation. The Company incorporated those charges in the August 1, 2022, rate change going forward.
