**Petition for 2023 Qualified Capital Project Adjustment Charge**

**Order Authorizing Tariff Implementation**

**O R D E R N O. 26,906**

**November 29, 2023**

In this order, the Commission accepts the tariff filings submitted by Pennichuck Water Works, Inc. (PWW) to implement the 2022 Qualified Capital Project Adjustment Charge (QCPAC) approved by Order Nisi No. 26,875 in this proceeding. In that order, the Commission approved a 1.36 percent of base revenue increase for projects placed in service in 2022. The commission also approved an additional charge to recoup the 2023 QCPAC from April 26, 2023 (date of filing of the 2023 QCPAC petition) until the effective date of the order (August 21, 2023). The recovery of the additional charge was to be collected over a three-month period.


PWW has filed compliance tariff and filed a final calculation of the surcharge. For the typical residential single-family customer, the monthly recoupment for 3 months is \$2.10 per month. See October 10, 2023 filing, Attachment at page 3. On October 16, 2023 the New Hampshire Department of Energy (DOE) filed its recommendation stating that it had reviewed the revised monthly recoupment calculation filed on October 10, 2023, and found no exceptions to the calculations in the revised recoupment filing.

The Commission issued a compliance letter on November 15, 2023 accepting the tariff filings. Accordingly, the Commission determines PWW has now properly calculated the additional charge to recoup the 2023 QCPAC and PWW has authority to implement the tariff filed in this proceeding.


