#### Affidavit of Notice Compliance

On May 18, 2023, the NH Public Utility Commission ("Commission") by Order *Nisi* No. 26,824 ("Order"), as amended on May 22, 2023, approved Pennichuck East Utility, Inc.'s (hereinafter "Company") Petition for Approval of Refinancing of a CoBank, ACB Balloon Maturity (T4) Note, in Docket No. DW 23-024. By the terms of the Order, the Company must file evidence of the finance closing and interest rate within fifteen (15) days of the closing. On June 16, 2023, the Company closed the refinance loan with CoBank, ACB in the amount of \$1,025,000. The final interest rate of the loan is 6.23% over a 10-year, fully amortizing term. This Affidavit is filed as evidence of the loan closing and final interest rate in compliance with the terms of the Order.
