## Re: DE 23-026 Electric Distribution Utilities Potential Jurisdictional Conflicts Related to Authorization of Pilot Programs Under RSA 362-A:2-b

Dear Chairman Goldner:

On September 6, 2023, the Commission granted the request of the Community Power Coalition of New Hampshire ("CPCNH") to have its counsel, Michael Postar and Gelane Diamond, participate remotely in the oral argument in this proceeding because Mr. Postar and Ms. Diamond are based in Washington, D.C. and travel to New Hampshire would be inconvenient.
