Request for Change in Distribution Rates
Revised Temporary Rate Schedules**

Dear Chairman Goldner:

On June 26, 2023 Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty's (the "Company") updated revenue requirement and rate schedules reflecting the settlement reached with Department of Energy ("DOE") and the Office of Consumer Advocate that was presented at the June 21, 2023 hearing before the New Hampshire Public Utilities Commission (the "Commission").¹ Temporary rates consistent with this settlement were approved by the Commission on June 30, 2023 pursuant to Order No. 26,855. The Company subsequently discovered a typographical error in the updated schedules with respect to the G-1 Customer Charge pursuant to which two numbers in the charge were transposed. The Company is therefore enclosing a revised version of Exhibit 3 that includes updated versions of Attachments KMJ/DSD/GHT-Temp-2 and KMJ/DSD/GHT-Temp-3 to correct this error. The change in the G-1 Customer Charge does not change the overall percentage increase to distribution rates as approved in the Commission's Order.² Attachment KMJ/DSD/GHT-Temp 3 has also been updated to include the revenue requirement for Rate M (Lighting) that supports the information presented in Attachment KMJ/DSD/GHT-Temp-5, discussed below.

At the request of the Department of Energy ("DOE"), the Company is including Attachment KMJ/DSD/GHT-Temp-4 which is the revised revenue provided informally to DOE on June 27, 2023 in support of Attachment KMJ/DSD/GHT-Temp-2. Finally, the Company is also enclosing Attachment KMJ/DSD/GHT-Temp-5 which provides the Company's authorized revenue per customer used as the benchmark for revenue decoupling purposes.

² The change in the G-1 Customer Charge does slightly change the Base Distribution Revenues from \$47,150,711 to \$47,142,907.
